**LAND MANAGEMENT & RESORATION - STEWARDSHIP**

**THE FEDERATION'S HABITAT CONSERVATION PROGRAM WAS ESTABLISHED IN 2012 AND HAS COMPLETED NUMEROUS RESTORATION PROJECTS. SEVENTEEN WETLAND RESTORATION PROJECTS TOTALING MORE THAN 1,200 ACRES ARE COMPLETE AND THREE OTHERS ARE IN VARIOUS STAGES OF PERMITTING. SIX STREAM RESTORATION PROJECTS TOTALING NEARLY ELEVEN MILES OF STREAM ARE NOW COMPLETE, AND THREE ARE IN VARIOUS STAGES OF PERMITTING. THERE ARE TWENTY FIVE ACTIVE FOREST RESTORATION PROJECTS TOTALING MORE THAN 15,000 ACRES, AND TWO GRASSLAND RESTORATION PROJECTS TOTALING MORE THAN 400 ACRES.
